

Water Safety Ireland Kildare Child Safeguarding Statement

1. Name of service being provided: Water Safety Ireland Kildare

2. Nature of service:

Water Safety Ireland Kildare delivers swimming, lifesaving and water safety training and education to members of the public in swimming pools and at open water venues e.g. beaches, lakeshores & riverbanks. Water Safety Ireland Kildare operates under Water Safety Ireland the internationally recognised Governing Body for the sport of Lifesaving.

3. Principles to safeguard children from harm:

WSI Kildare recognises that the welfare and interests of children are paramount in all circumstances. It aims to ensure that all children have a positive and enjoyable experience while in its care and are protected from any harm or abuse whilst participating in all activities. It acknowledges that some children, including those less able can be particularly vulnerable to abuse or harm and accepts its responsibility to take reasonable and appropriate steps to ensure their welfare by working with the child's parents or carers.

As part of our safeguarding policy Water Safety Ireland Kildare will:

- promote and prioritise the safety and wellbeing of children and young people
- ensure everyone understands their roles and responsibilities in respect of safeguarding and is provided with appropriate learning to recognise, identify and respond to signs of abuse, neglect and other safeguarding concerns relating to children and young people
- ensure appropriate action is taken in the event of incidents/concerns of abuse and support provided to the individual/s who raise or disclose their concern
- ensure that confidential, detailed and accurate records of all safeguarding concerns are maintained and securely stored
- prevent the deployment of unsuitable individuals and maintain a safe recruitment and vetting policy
- Ensure that robust safeguarding arrangements and procedures are in operation.

5. Procedures

Our Child Safeguarding Statement has been developed in line with requirements under the Children First Act 2015, *Children First: National Guidance for the*

Protection and Welfare of Children (2017), and Tusla's *Child Safeguarding: A Guide for Policy, Procedure and Practice*. In addition to the procedures listed in our risk assessment, the following procedures support our intention to safeguard children while they are availing of our service:

- Procedure for the management of allegations of abuse or misconduct against workers/volunteers of a child availing of our service;
- Procedure for the safe recruitment and selection of workers and volunteers to work with children;
- Procedure for provision of and access to child safeguarding training and information, including the identification of the occurrence of harm;
- Procedure for the reporting of child protection or welfare concerns to Tusla;
- Procedure for maintaining a list of the persons (if any) in the relevant service who are mandated persons;
- Procedure for appointing a relevant person.

All procedures listed are available upon request.

6. Implementation

We recognise that implementation is an on-going process. Our service is committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm while availing of our service.

This Child Safeguarding Statement will be reviewed on 1st May 2020 or as soon as practicable thereafter or if there has been a material change in any matter to which the statement refers to.
